COVID-19 Prevention:

The Local Organizing Committee understands the realization of an international FIS-Cup during a pandemic as a privilege. For this reason, we will execute a 'zero tolerance policy' for deviations from legal regulations and FIS/OESV(Austrian Ski Federation) guidelines. The health and safety of everyone involved in the competition has the highest priority. Athletes, Team-Captains, officials, jury, LOC and volunteers are responsible for their compliance with the statutory regulations, and prevention guidelines in their respective areas of activity.




Each participant and the National Ski Associations confirming with their entry, to comply with national legal requirements, and guidelines by the FIS and the Austrian Ski Federation (OESV).

Risk Mngmt & Testing Protocol

The Risk Management and Testing Protocol for the Villach venue is based on 'Statutory Requirements' (Sozialministerium)', the 'FIS Covid-19 Risk Magmt & Testing Protocol' and the 'Ski Austria Covid-19 Guidelines'. The guidelines will minimize the risk of COVID-19 transmission during the event and to enable athletes to participate on following competitions. The LOC utilizes also a separate 'COVID-19 Prevention concept' document, in alignment with the 'Austrian Ski Association', the management of the 'Villacher Alpen Arena' and 'Local Authorities'.

TESTING PRIOR TO ARRIVAL at Event / Venue ("Pre-entry") and HEALTH QUESTIONNAIRE

The venue is secured to prevent unauthorized access in the period from Friday 9am until the end of the competition on Sunday afternoon. There are five population groups that are subject to compensatory adherence of this protocol:

- 1. Athletes, Team Support Staff, Equipment Service
- 2. FIS Officials
- 3. Media1
- 4. Other Accredited Groups (identified through close working relationships with Group 1 and 2)
- 5. Local Organizing Committee (identified through close working relationships with Group 1 and 2)

It is of the utmost importance that the groups do not mix amongst each other but stay separate in their own bubbles (inside and outside the competition areas!).

UPDATE: Every person who wishes to access the FIS Cup Event must have and present a **negative Covid-19 RT-PCR Test result carried out not more than 48 hours prior to arrival/accreditation.** The LOC will accept negative PCR test results, which were taken no earlier than on Wed. Feb. 16th.

The <u>pre-testing requirement is mandatory for all accredited individuals</u> (as identified in population groups above) <u>regardless to immunity and vaccination status</u>.

It is expected that the stakeholders make their own arrangements to have an up-to-date RT- PCR test result uploaded to the 'Ski Austria - Registration & Covid-19 Health Questionnaire' system, to facilitate their access and accreditation.

This includes testing in case of symptoms and <u>testing after every 48 hours for non-vaccinated</u>. In other words, <u>Covid19 vaccinated</u> (valid vaccination status) persons do not need to undergo on-site testing after providing the initial PCR test upon arrival.

You can find certified COVID-19 test facilities close to the venue here: 'VILLACH TESTET'. The test facilities typically delivering results within 24hrs after conducting the test.

Please contact/inform the LOC Health coordinator (Franz Wiegele +43 676 838 40228) in case of any Covid-19 related issue or question to align on further proceeding.

Any positive test result needs to be reported to local authorities **1450** whom will apply procedures for contact tracing and isolation in accordance with national regulations.

Daily Health Check

Based on OESV / Austrian Ski Federation guidelines every single competitor, coach, staff, and LOC members need to fill out a 'Registration & Covid-19 Health Questionnaire'. A link will be provided prior to the TCM to all 'On Venue Contacts' as registered in the FIS Competition Entry System.

In case a team member shows symptoms (fever, chest pain, headache, nausea/vomiting, or loss of taste/smell) inform immediately the LOC COVID-19 Health Coordinator – to align on further proceeding.

Use of Masks

Every person in the restricted area of the Villacher-Alpen-Arena must wear a FFP2 or equivalent KN95 mask without exhaust valve. Masks should be worn (covering mouth and nose) by all accredited individuals regardless of immunity and vaccination status.

Exceptions: When drinking or eating and athletes during sport. Athletes may remove the mask after equipment check at the starting area of the hill. In addition, every Person must maintain a 2m distance from other persons.

TCM

The TCM will take place in the Arena-Café with a 2m distance between attendees. Only the Team Captain or one representative of each competing team can attend the TCM in person. Jumping judges, Timing and Data Service employees shall attend online via a ZOOM meeting. A link will be provided prior to the TCM to all 'On Venue Contacts' as registered in the FIS Competition Entry System.

Team-Home and Toilet Facilities

Venue facilities and restricted areas are indicated schematic on page 5. The toilet facilities next to 'FIS Equipment Check' room, is restricted to participants of the event only. Please keep always the 2m minimum distance to other people.

We ask EVERYONE, to TAKE RESPONSIBILITY and comply by all means with requirements and guidelines as listed above! Stewards and LOC members might check and enforce the COVID-19 requirements. We will be most effective, if EVERYONE simply adheres to the requirements for his/her own safety and the safety of others.

In case of violation or non-compliance with the COVID-19 guidelines, we reserve the right to exclude concerned persons from the event and take legal action.

19:00	Team captains' meeting → in the Arena Café; One member per team with FFP2 / KN95 mask. Ewoxx, Jumping Judges & other officials shall participate online. A ZOOM link will be provided to all 'On Venue Contacts' (as registered in the 'FIS Competition Entry Service')
