## General Information

The competitions are organized based on the International Competition Rules (ICR) as published on the FIS Homepage. All competitors participating in FIS events must carry accident insurance in sufficient amounts to cover accident, transport and rescue costs including race risks, as well as an appropriate third party liability insurance.

The National Associations are responsible for adequate insurance coverage of all their competitors sent and inscribed by them. The NSA or their competitors must be able to show proof of the respective insurance coverage at any time on request of FIS representatives or the OC (ICR 212.4)

## Entries

NSAs/Teams need to maintain entries through the FIS Online Entry System in the member section of the FIS Homepage

**Preliminary Entries:**

- Number of athletes and staff
- Number of single and double rooms Final Entries
- Entries by name Onsite contact information
- The LOC will distribute further information to contacts as registered by NSAs in the FIS entry system.

## Accommodation

Participating teams must enter their competitors prior to the published entry deadline.

## Reimbursement

The Organising Committee is responsible for reimbursing the cost of travel and accommodation according to FIS rules. Expenses will be paid through bank transfers.

## Prize money

Prize money will be paid by the Organizing Committee electronically through bank account transfers, as defined in the 'InterContinental Cup Rules Women Ski Jumping'. NSAs are responsible for entering the personal bank information for each athlete using the FIS Athlete Registration module in the FIS Member Section. The Organising Committee will deduce a withholding tax for non Austrian citizens, in conformance to the Austrian law. Athletes are responsible for any applicable withholding/income taxes in their respective country of residence.
